As such, eligible SMEs receive up to \$15,000 in reimbursement funds to develop a digital adoption plan. The grant covers the cost of retaining the services of an approved Digital Adoption Consultant (DAC). All clients selected for DMAP grant will need to contract with an eligible Digital Adoption Consultant registered on the DCC roster to develop their Digital Modernization and Adoption Plan (DMAP) and will need to submit their completed plan.
