The Digital Modernization and Adoption Plan (DMAP) program supports Ontario SMEs to better understand their organization's technology needs, guide their digital transformation decision-making, and optimize their technology investments. Through this program, SMEs work with a **Digital Adoption Consultant [DAC]** to generate a Digital Modernization and Adoption Plan tailored specifically to their organization's digital needs.

This program is administered through **Ontario Centre for Innovation (OCI)**.

Applicants may be eligible for the OCI – Digital Modernization and Adoption Plan (DMAP) program if they:

- Must be incorporated federally or provincially with a valid Business Number
- Must be a for-profit, privately owned business
- Have between 1-499 FTEs and
- Have a permanent establishment in Ontario



Eligible Activities

Projects may be eligible for funding under this initiative if they:

- Support your organization to generate an effective Digital Modernization and Adoption Plan in order to enable digital adoption and transformation in the SME and drive productivity increases and company growth; or
- Must contract with an eligible Digital Adoption Consultant (**DAC**) from the DCC roster to develop their Digital Modernization and Adoption Plan (**DMAP**)

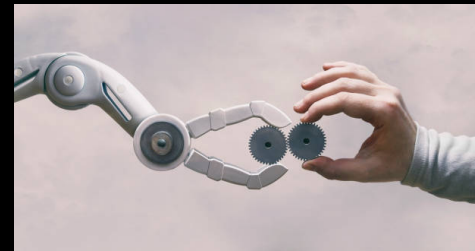
