

## 2024 ONTARIO LIFE SCIENCES INNOVATOR AWARD

### ABOUT THE AWARD

The Ontario Centre of Innovation is proud to launch the Ontario Life Sciences Innovator Award, designed to recognize a top entrepreneur leading an Ontario based life sciences company that has demonstrated significant impact in the sector.

This impact can be evidenced through **(1) Innovation**: Introduction of new technologies, therapies, or products that address unmet medical needs or improve existing solutions. **(2) Economic Growth**: Creation/retention of jobs, attracting investment **(3) Disruptive Impact**: New advancements in scientific research, leading to new discoveries, publications, and patents that push the boundaries of life sciences, placing Ontario as the forefront of the Life Sciences sector. **(4) Health Outcomes**: Improvements in patient care, treatment efficacy, and overall public health due to the implementation of new medical technologies or practices.

The top innovator will receive an award recognizing their contributions in the Ontario Life Sciences sector, presented by the Minister of Economic Development Job Creation and Trade at the OCI Annual General Meeting. And will be featured on OCIs social media, including a story in the FY24-25 OCI Annual Report.

### NOMINATION CRITERIA

- Eligible innovators must be leading an Ontario based life sciences and healthcare technologies company related to human health. Note: Ontario or Canadian incorporated for-profit SMEs headquartered in Ontario

Note: Exclusions, agrifood and industrial biotechnology.

### HOW TO SUBMIT

- All applications must be submitted by September 13, 2024, **extended to September 22, 2024.**
- Applications will be reviewed by a panel made up of both internal and external leaders in the Life Sciences sector and only the top 3 applications will move forward to the voting period of the process.
- The top 3 innovators will be featured on the OCI website, entrepreneur, photo of the innovator, company description, company logo, voting buttons.
- Individuals will be able to vote for the innovators that they deem have demonstrated the strongest impact in the Life Sciences ecosystem based on one or more of the impact areas: (1) Innovation, (2) Economic Growth, (3) Disruptive Impact and/or (4) Health Outcomes
